CIRCULAR

The Board has decided to make the manual processing and issuing of certificate of Origin, which is mandatory for export of 'Darjeeling tea' completely online and launch an online portal <https://www.darjeelingteaIndia.com/> to issue such Certificate of Origin (CoO) as part of its effort to have a traceability mechanism to map the movement of Darjeeling tea from the stage of plucking of green leaves to export consignment from 3rd April, 2023 with following features:

1. Cost effective as the processing fee for each CoO above two kilogram of tea has been fixed at Rs.800/- plus applicable GST;
2. Simple, user friendly, customer help desk (during office hours), completely paperless and works 24X7;
3. Ensures transparency providing scope for each exporter/importer to check the source of Darjeeling tea;
4. Easy MIS generation on green leaf plucked, total tea manufactured, garden invoice, country of export, quantity of tea exported etc to both Tea Board and the Producers;
5. Assured confidentiality of all commercial data and information.
6. Scope for extending the system for domestic trade of Darjeeling tea

The system launch has been discussed with all stakeholders and for smooth transition from off-line mode to online mode, the old offline mode shall also continue till 1st of August, 2023. Exporters can avail either of the system as per their convenience.

The Darjeeling Tea Association shall provide all the details of CoO issued in the last two years (after 1.1.2021 till 1st August 2023) to the Board/Agency working on behalf of the Board for updating the database of the traceability system.

The Darjeeling Tea Association shall return all hardware and software of the existing system to Tea Board within 15 days after 1st August, 2023.
